- Pools: contractor to caulk pool on Pegasus, remove/replace sand from pumps at both pools, and repair light at the pool on constellation; Motion was made by Mike Wilson to accept the McCaffety Electric bid on changing out the lights at the Constellation pool cost \$1,431.00, and CNR to go ahead with the replacement of Sand filters in the pump at both pools also to replace caulking at the large pool (120 linear feet), total cost \$4,056.00. seconded by Brenda Wendt, and passed unopposed
- Repair the lights at the Marina Peninsula. Motion was made by Sarah McDowell to table until we have McCaffety Electric come out and bid on repairs. Seconded by Brenda Wendt, and passed unopposed.

- Adding Security cameras; Motion was made to table until we have a full scope from Boyd Tech by Brenda Wendt. Seconded by Starling Ishee, and passed unopposed.
- Motion was made by Mike Wilson to remove two bank accounts that were opened
 up one for the Marina Reserve Account and the other for POA Reserve and move
 it back to the CIT Account, seconded by Brenda Wendt, and passed unopposed.
- PA Board Election information/ timeline. Brenda Wendt Chairman of Election Committee read the timeline of dates and information on positions available, packets will soon be available at the POA office.

- Pond Service contract, Motion was made by Brenda Wendt to accept the contract for the ponds with Aqua Tek, seconded by Mike Wilson, and passed unopposed.

- Marina toilets and PA Office toilet to be replaced with standard units.
- Summerchase Letter concerning drainage, Steve Hake reported we sent a letter to the developer of Summerchase concerning the drainage issues on streets, they responded we are reviewing the situation with an engineer and will be moving forward into finding a solution.
